LEARNING EVENT: Nexus CC/DRR- Fragility 6 November 2018; 9:15 – 16:15, Helvetas office, Bern

The political and social context can determine how disaster and climate risks impact people's lives and how well they are able to recover. This requires a thorough awareness and understanding for a successful consideration of Disaster Risk Reduction (DRR) and Climate Change Adaptation (CCA) mechanisms to adjust and improve coordination, advocacy and advice. This is particularly important but also complicated in the case of conflict affected and fragile contexts, when governance mechanisms and institutions are generally weak. Nevertheless, humanitarian aid as well as development cooperation programs and projects of Swiss NGOs and SDC are often located in fragile and conflict affected contexts. This learning event sensitised practitioners on how climate and social risks can be minimized in a systematic way when planning and implementing projects and programmes in fragile and climate settings and foster the affected linkages with disaster This was done through two main elements: the experts participating in the workshop exchanged experiences in a group work and through a case study. Moreover, a new approach to tackle risks in fragile contexts combining climate change, disaster risk reduction and conflict sensitivity (based on the 3 steps manual working in fragile and conflict affected contexts and CRiSTAL / CEDRIG risk assessments) which Helvetas has elaborated was shared with the group. First hands-on experience from the testing in Borana in Ethiopia was presented.

Learning event

The event was addressed to NGOs practitioners and staffs of SDC involved in projects and programmes working in disaster affected and fragile situations.

Objectives: Enhance the thematic competences of participants in the field of DRR/CCA in fragile and conflict affected situations:

- i) Experts exchange experience about practices, lessons learned and challenges in the field of DRR/CCA in fragile and conflict affected situations;
- ii) Participants have a better understanding about the interlinkages between DRR/CCA and conflict;
- iii) Participants are sensitized on how potential risks are minimized in a systematic way when planning and implementing programs in a climate and fragile affected contexts.


Part 0: Welcome & Introduction

The facilitators shared the main objective of the day and highlighted the key aspects of the upcoming event.

After an introduction round, the expectations of all the participants were collected and shared in the plenary. The expectation expressed by the participants matched well with the expected results identified.

The expectations expressed by the participants focused mainly on learning more on the nexus CC/DRR-Fragility and to learn about the **HELVETAS** instrument which Swiss Intercooperation is currently developing.

Expectations expressed by the participants

Part 1: Refresher on Fragility/Conflicts and DRR/CC

Presentation on fragility and social conflicts

Key elements: Most of the countries we are working in today in the context of development cooperation are not stable. It is important to distinguish that it is not always the entire country which is not stable, but only certain regions (e.g. Colombia).

At the international level: Peace and Stability has been integrated into the SDGs, particularly SDG 16, which means that we need to link development with peacebuilding.

Sharing of the 3 STEPS for Working in Fragile and Conflict affected Situations, approach developed by HELVETAS and Swisspeace. There is a manual¹ and a field guide² available.








<u>The presentation on DRR/CC</u> as an introduction was skipped since all participants have experience in working in disaster risk reduction and/or climate change.

Presentation on Nexus CC-Fragility

Key elements: While it is clear that violent conflicts within states are increasing worldwide and the tendency of extreme weather events in terms of frequency and intensity as well, the relationship between CC and violent conflicts is not always clear. It is also important to emphasize that climate change is not the only driver of conflict, but rather a stress multiplier that can lead to a heightened risk of violence and conflict in an already instable setting.

At the international level, there are various international frameworks (Sendai, UNFCCC, Roadmap for Peaceful just and inclusive societies) taking into account the nexus between Climate Change and Conflict, yet there is no joint framework/platform to tackle the issues related to this nexus (e.g. as the disaster displacement platform on the nexus migration-CC).

<u>Case Study 1: DRR programming in fragile context – Experience from Swiss Red Cross in</u> Honduras and El Salvador

Key elements: Both countries are characterized by a very high homicide rate (one of the highest worldwide) and are at the same time highly prone to all kind of disasters. The SRC program is multisectoral with a focus on health, social inclusion and the strengthening of DRM/CC. Due to conflicts/violence, SRC had no access to the communities. The toolkit CSPM is very helpful as it is a learning journey to go through in a participatory approach.

Lessons learned: Plan for the worst, hope for the best, to be flexible is key in such conflict affected contexts. Invest in training and awareness raising for your staff; focus on changes (outcomes rather than on activities). It is particularly important to have alternate solutions, especially in conflict and violent contexts where projects need to be adapted.

Group Work 1: Experience Exchange

Questions to discuss in your group:

- 1. What did you find particularly interesting or surprising in the Swiss Red Cross' presentation?
- 2. How does this relate to your own work/the work of your organization?
 - How do you tackle the nexus of climate change and fragility/conflict in your organization?
 - What are the most challenging issues?
 - What interesting experiences would you like to share with your colleagues?
 - What do you plan to do in the future around that topic?

Filter out the 3 most important key messages from your discussion (considering the different experiences and/or challenges of all organisations present in the group) and share them in the plenary (e.g. cards/flipchart, human photos etc.)

Key messages

- Use DRR as an entry point for natural resource governance
- Work with non-traditional development actors (e.g. IUNC; WWF) in ecosystem-based DRR
- Value traditional and indigenous knowledge
- No stand-alone DRR → need to link to other issues
- Building up trust is key
- DRR can act as a door opener/neutral entry point to discuss more sensitive issues related to conflicts
- DRR as an entry point for natural resource governance
- No standalone DRR → need to link it to other issues

Challenges

- Weak institutions, migration short-term funding as a challenge to nexus approach
 - a challenge to
- Trust more challenging in a fragile context, but the more important in fragile context
- Careful not to mix up different things (not to mix up CC and DRR)
- What happens when the project finishes (power game)
- Vulnerabilities caused by a project and projects addressing vulnerabilities
- Neutral entry point



<u>Case Study II: Towards a comprehensive risk management approach for climate resilience, conflict sensitivity and transformation developed by HELVETAS Swiss Intercooperation</u>

Key elements: Orientate and support practitioners working in the context of conflicts. It is not a new tool but combines existing approaches in the field of fragility and climate change (e.g. 3-Step Approach to working in fragile and conflict-affected situations; CRISTAL, CEDRIG). This joint approach leads to a series of **six steps**, structured in **MODULE A** and **MODULE B**. The instrument has just been tested in

Borana Ethiopia and first results were shared during the workshop. The diverse feedback received by the participants during the LE will also help to adjust the instrument. HELVETAS intends to apply the instrument in one or two other occasions and to finalize/adjust the tool accordingly.

Most of the afternoon was then dominated by the discussion on the usefulness of such an instrument developed by HELVETAS. No time was unfortunately left for the 2nd group work which should have focused on an exercise on systems mapping by using two concrete examples (SRC

case study and one example of HELVETAS in the North of Mali).

In conclusion, the LE on the nexus fragility – CC/DRR has confirmed the importance of analysing this nexus in more detail to better understand how these two issues influence each other. Most of the members of the Swiss NGO DRR Platform who were present expressed interest in further exploring the issue. HEKS, for instance, showed particular interest in applying the instrument currently under development by HELVETAS.
